MINUTES

MARCH 21, 2007

The final meeting of the season was called to order by President, Larry Tucker at 6:30 p.m.; with 23 members in attendance.

SECRETARY'S REPORT

June Opsitnick, Secretary handed out the minutes in advance to the members from the February 21, 2007 meeting. Minutes were reviewed and accepted.

TREASURER'S REPORT

Ray Racicot reported that as of 3-21-07 the club balance consisted of the following:

Ray informed the members that he will be investing \$12,000 into a six month CD; estimated interest will be approximately \$300. Ray commented there were 188 Sam permits sold this year, down 40% from prior year. Club members accepted the treasurer's report as presented.

Ray stated that Flamingo will be selling memberships and permits next season as in the past. Suggestion was made to push the memberships next season with permits being purchased after the season starts. Discussion on this issue will continue.

Audit of the club's books was conducted on March 20, 2007 by Bill Lyons and June Opsitnick. The books were in good standing order and will be audited on a yearly basis. Question arose as to whether the Treasurer or entire Board was bonded, Larry to check with SAM on this issue.
